AND all the estates, rights, title and interests, claims and demands of the Settler upto, upon or out of the said sum to HAVE AND TO HOLD the said sum upto and to the sue of the said Trustees and upon and subject to the Trust, powers and provisions hereinafter declared and expressed by and agreed between the parties hereto as follows:

2. THE TRUST FUND:

2.1 The Trustee shall stand to be possessed of the said Trust fund upon Trust and also

to receive any income or interest, dividends thereof and voluntary contribution, donation and gifts and in the first place to reimburse themselves (other Trustees) or pay or discharge all the costs, charges and expenses incurred in or about on incidents of the institutions or execution of Trust and other taxes and cost of meeting of ordinary repair to any immovable property.

All the incomes, earnings, moveable, immovable properties of the Society shall be solely utilized and applied towards the promotion of its aims and objectives only as set forth in the Memorandum of Association and no profit on them shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever, to the present of past members of the society or to any person claiming through anyone or more of the present or past members. No members. No members of the society shall have any personal claim on any movable or immovable properties of the societies or make any profit, whatsoever by virtue of this membership.

4. INCOME OF THE TRUST AND ITS MANAGEMENT:

The Trust shall be entitled to accept upon such terms as Trustees think fit, any donations, grants, subscriptions, aid and contributions, from any individual, Government, local authority, corporation, firm, company, syndicate, association or other person or from any charitable or other institution, And to acquire by purchase, lease or otherwise any property weather movable or immovable or any rights for the purposes of the trust and to sell, give on lease, thortgage or otherwise transfer any such property or rights provided further that notwithstanding anything herein before or hereinafter contained, the said income (as also the corpus) of the Trust fund shall be applied and be applicable only to or for such charitable purposes only and within such territories only and subject such conditions or limitations if any as may from time to time be laid down in the income Tax: Act, 1981 or any other Act in modification or substitution thereof governing taxation of income for the time being in force as well ensure or earn or make the Trust hereby established and its income eligible for exemption for taxation under the income Tax Act 1961 of any replacement re-enactment or modification thereof and further so that the said Trust hereby established shall be one to which the provisions of Section 80 G of the Income Tax Act, 1961 or any re-enactment or modification thereof shall apply so that the donation to the Trust be recognized as eligible for exemption from income tax in regard to the donor.

If at any time, the said Trustees shall be desirous of handing over entirely or in part the said Trust fund, and its accumulated income to any institution or any other Trust which is recognized under Section 80-F of the Income Tax Act 1951 or any statutory modification or re-enactment thereof for the time being in force or to any Governmental or other authority or to the Union or State Government, they shall be entitled to do so on such terms and conditions as

they may think fit.

It is intended and directed that if at any time hereafter it is held that any of the objects or purposes to which the said income or any part thereof (or corpus of any part thereof) is directed to be applied to or extended for, is not a Public Educational/Charitable/Social/spiritual object or purpose (the benefit whereof is not restricted to any class or community) according to law, then in that case the said Trustees shall apply and expend the said income (or corpus) towards the execution and carrying out of only such of the objects and purposes or such other object or purpose of Public/Educational / Charitable / Social / Spiritual nature, which are and the benefit whereof is not restricted to any

class of community as the said trustees may think fit, subject nevertheless to the directions or limitations contained in clauses 1 and 2 thereof.

4.4 The surplus and unapplied portion of the income of the Trust, if any, arising in any one or more year or years may be accumulated by investing the same and the resulting income thereof from time to time in any of the investments in which the said Trust Fund is hereby directed or authorized to be invested and may be credited to an account in the books of account and the said Trustees shall have the power in any subsequent year to expend any apply the same in the same manner and to the same extent as if such accumulation or part thereof had been part of the said income of the year or years in which the same is sought to be expended and applied as aforesaid.

4.7 The said Trustees shall invest and keep invested all the said Trust fund in their hands as also the interest or any other incomes thereof, if any, for the time being in their hands not immediately required for the purposes as aforesaid in one or more of the securities and investments authorized by and specified in section 20 and 20a of the Indian. Trusts Act, 1982 and/or in deposit in current call deposit short deposit or fixed deposit account in any scheduled bank or banks and in a manner permitted by Section 13 (i) (d) read with section 13(5) of the Income Tax Act 1981 or any re-enactment of

10.8 That the trustee may delegate all or any of the power / authorities and discretions herein before conferred of them to any committee or committees for the routine and day to day management and administration of any such institution under their ultimate supervision and control for such period as may be specified in the deed or deeds appointing the committees.

10.9 To accept all the assets of any other Trust / Society or instructions having similar objectives to those of this Trust in the event of any such trust / society or

Institutions decide to hand over such properties by way of resolution.

10.10 That, the Trustee is also empowered to appoint any one of his wards as his successor Trustee. However, in the event of sudden demise or death or incapability of Trustee, the wards of the Trustee, if she/ he is a major or on their attaining the age of majority, shall automatically be appointed as Trustee to fill up the vacancy arise subject to the declaration / will of the demised Trustee and will continue to act as such for their life unless otherwise the ward himself / herself voluntarily give in writing of her / his intention not to continue as member of the Trust.

The number of such additional Trustees shall be more than five.

10.13 Instead of themselves spending any such amount for any purpose authorized by these presents or by law or statute the said Trustee may pay any sum of the purpose of such expenditure to the Treasurer or Secretary or other official of any institution without being bound to look after the application thereof and the receipt of any such Treasurer, Secretary or official shall be a complete discharge to the Trustees for such payment and for seeing to the application thereof, subject to necessary permission required under any law for the time being in force relating to public trust.

10.14 To grant leases for such period and on such rent and on such terms and conditions (including an opinion to the lessee to purchase) as they may think fit and to accept surrender of any lease and IT IS HEREBY DECLARED that any permit or fee shall be treated as income or as capital or partly as

income and partly as capital as the said Trustees may think fit.

10.15 To reimburse themselves or pay and discharge out of the funds or any property subject to the trusts of these presents and income thereof all expenses that may be incurred in or about the execution and administration of the said trusts and powers on these presents.

10,19 Trustees in carrying out the objects of the Trust shall be entitled to acquire by purchase or on lease or otherwise immovable properties of any-tenure and in case of vacant land the Trustees shall be at liberty to erect buildings thereon to do all acts necessary and incidental thereon.

10/20 It shall be lawful for the Trustees to pull down, renovate, rebuild, alter, adopt, improve, aid to , develop or repair any immovable property belonging to the Trust and to spend such amount for the same as may be necessary.

10.21 The Trustees shall have power to raise funds by way of loans in carrying out the objects of the Trust.

10.22 The Board of Trustees shall have full control as regards regulation, management, application and administration of the Trust Fund and its properties whether capital or income, rent, interest and profit, as well as movable and immovable properties.

10.23 Receive on behalf of the trust such contributions, donations and gifts in from


