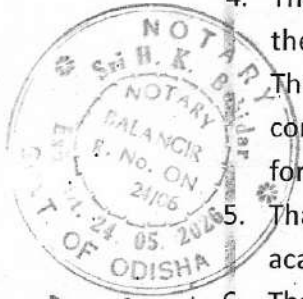

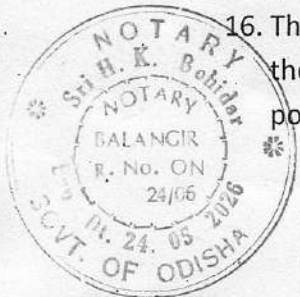
AFFIDAVIT
